3. Bidding will be conducted in accordance with the **open domestic bidding** method contained in the Government of Uganda's Public Procurement and Disposal of Public Assets Act, 2003 and is open to all bidders.

The Bidding documents in *English* may be purchased by interested bidders on the submission of a written application to the address below at 8(b) and upon payment of a non-refundable fee of **UGX: 300,000 (three hundred thousand only).** The method of payment will be **by Cash to the National Medical Stores Cashier at the address in 8(a) below. The date for the pre-bid meeting shall be 21st January 2015 at 12.00 noon after site visit at Kajjansi at 10.00am**

Bids must be delivered to the address below at 8(c) at or before **11.00am on 9th February 2015.** *All bids must be accompanied by a bid security of 2% of the total contract price in Uganda Shillings or an equivalent amount in a freely convertible currency. The bid security must be valid until 29th July 2015.* Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at **11.00am on 9th February 2015**
